



Scholarship Program 2020-21 Dance Season

Please note carefully the following before submitting your application:

- A fully completed application must be submitted no later than August 15, 2020. Completed applications may be mailed to or dropped off at the studio office (3356 Ironbound Rd., #501, Williamsburg, Virginia, 23188), or submitted electronically to iDance Board Treasurer Rich Paulk at rich@rcpainc.com.
- No application can be considered without complete supporting documentation.
- Each dancer is eligible for tuition assistance covering up to three hours of classes per week.
- Scholarships cover a portion of tuition ranging from 25% to 100%. The portion is variable, depending on situation and available funding.
- Families receiving partial scholarships are still responsible for timely payment of the reduced tuition rate. Standard late fees will apply to any balance due from the family.
- Scholarships MAY NOT be combined with any other financially subsidized program offered by iDance, including the Junior Boys' Scholarship Program.
- Priority for all scholarship awards will be given to families not already receiving other tuition discounts, including those families paying the family maximum monthly tuition.
- Scholarships are available to youth dancers only (18 years of age or younger at the time of application).
- All scholarship awards are determined by a subcommittee comprised of representatives from the iDance Board of Directors and the local community. While every effort will be made to provide scholarship funds to the families with greatest financial need, ultimately all awards are made at the sole discretion of the subcommittee.
- For families with more than one dancer, please complete an application for each student. However, only one set of supporting documentation is needed for these families.
- Awards are for a full year's tuition, but are paid in semester installments. Second semester awards are contingent upon the dancer's compliance with all conduct and attendance policies.
- Family accounts of scholarship applicants must be in good standing at the time of application.
- Scholarship awards DO NOT cover annual registration fees.
- Scholarship awards DO NOT cover the cost of costume fees. These expenses (\$55 - \$65 per costume) are the responsibility of the family.
- Scholarship awards DO NOT cover audition fees or production fees.
- Scholarship awards DO NOT cover any tuition or fees associated with The Movement Dance Company (TMDC).
- Dancers must apply for scholarship awards annually, and the same level of tuition assistance is NOT guaranteed each year.

The number and amount of scholarships awarded each year are variable and depend on availability of funds designated for this purpose.
