#### Rules:

- 1. iDance is not liable for any injury or lost/stolen property.
- 2. No smoking, burning incense or open flames anywhere in the building.
- 3. Renter may never leave any equipment, costumes, props or personal belongings anywhere on the premises.
- 4. Renter assumes responsibility for the security of the space during each rental period.
- 5. Renter is not to rehearse/practice/meet in non-rented space.
- 6. The iDance office & office equipment is off limits to Renters.
- 7. Renter is responsible for replacing any broken or damaged property caused by Renter and/or Renter's party.
- 8. Renter knows that the building may be occupied by others during the Term of this Agreement, including, but not limited to activities of iDance.
- 9. Renter is solely responsible for carrying his/her own liability insurance.
- 10. Renter is responsible for leaving the facility clean and removing all trash.
- 11. Renter will not assign Renter's interest in this lease or sublet the rented space to another.
- 12. iDance may terminate this Agreement immediately if Renter is found to have violated any Rule or provision of this Agreement. In the event of such termination, Renter and all guests thereof shall immediately vacate iDance premises.
- 13. iDance reserves the right to promulgate additional Rules, which in its judgment are needed for the general well-being, safety, care and cleanliness of the premises. Any such additional Rules shall be deemed to be part of this Agreement to the extent they do not materially alter the Agreement.

# iDance Liability Statement

By submitting and signing this Agreement, Renter certifies that it has read, understands and will abide by the provisions set forth herein. Renter hereby agrees to indemnify and hold iDance, its officers and employees free and harmless from any loss, damage, liability, cost or expense that may arise during, and be related in any way to, the use and occupancy of the iDance premises, whether or not such loss, damage, liability, cost or expense arises out of negligent acts or omissions of the Renter or its agents, invitees, employees, contractor, subcontractors, or students, unless such loss, damage, liability, cost or expense is due to the grossly negligent or willful acts of iDance. Renter understands that it will be responsible for any damages sustained to the iDance premises arising out of Renter's use and occupancy of the iDance premises. Any lost equipment or damages sustained to iDance property shall be compensated within seven (7) days. Renter agrees to fully compensate iDance for any expenses incurred due to a violation of the Rules promulgated by iDance, which include but are not limited to the Rules set forth above in this Agreement. Renter acknowledges and agrees that this Agreement is made with the understanding that The Institute for Dance, Inc. may cancel for any reason upon twenty-four (24) hour notice. iDance's liability for any breach of this Agreement is limited to the rental amounts actually invoiced pursuant to this Agreement. Renter is liable for any costs of collecting unpaid amounts due and owing under this Agreement, including court costs and reasonable attorney fees.

This agreement shall be construed under the laws of the Commonwealth of Virginia and any actions relating to this agreement shall be brought in applicable court in Williamsburg, Virginia.

If a court of competent jurisdiction holds any part of this Agreement to be unenforceable, the remaining provisions of this Agreement shall continue in full force and effect.

This Agreement constitutes the entire understanding between the parties and expressly revokes, replaces, and supersedes any prior agreements, written or oral. This Agreement may be modified only in a writing signed by agents of both iDance and Renter.
