

2026-27 IDANCE FAMILY CODE OF CONDUCT

At iDance, we hold our students, faculty, staff, and families to high standards regarding our mission, both in their study of dance and their behavior toward one another. To hold each other accountable, parents and students must agree to abide by the following rules of conduct as members of the iDance community, particularly when participating in iDance sanctioned events. We reserve the right to inform a student that they should seek instruction elsewhere if his or her behavior – or that of the parent, family members, or caregivers – is disruptive, disrespectful, or not in line with these basic standards of conduct.

STUDENTS:

- Learning is your priority in class.
- Be on time to class ready and prepared to dance; this includes following the dress code.
- Keep excellent attendance in all your dance classes. If you must miss, please let the office know in advance, if possible, and have a valid reason.
- Do not bring drugs or alcohol to any iDance activity (on- or off-site) at any time. We are a **ZERO TOLERANCE** community. If any student violates our code of conduct by participating in or turning a blind eye to any of these activities, they will be immediately dismissed from the studio – no longer permitted to take classes or participate in iDance activities. Parents will not be issued a refund.
- Be responsible for listening to announcements and making sure you bring home all notices and give them to your parents. • Have a positive attitude. When you have a question related to your instruction, politely ask your teacher by raising your hand or waiting after class.
- Be respectful of your peers, your teachers, and those around you while at the studio by silencing your cell phones, walking in the hallways, and speaking at a volume that is appropriate for indoor conversation. Please also make sure to clean up after yourselves and respect studio property.
- Be polite to everyone you encounter. This means you will not gossip; act as if you are better than other students in your class; use inappropriate or unfriendly language; be a bully, or intentionally harm another student physically or verbally. • Report bad behavior to the appropriate people. If you see someone being bullied or misbehaving in a way that could harm you or others or interrupt learning, please ask them to stop and let your teacher or a staff member know immediately.

PARENTS:

- Please get your children to class on time and be prompt in picking them up.
- Please notify the office of all absences and carefully abide by the attendance policy.
- Please label shoes and gear with the student's full name and **do not allow them to wear dance shoes outside.**
- Please make sure that your child is properly outfitted for class each week per our studio dress code, this includes leaving jewelry (including Fitbits & Apple watches) and valuables at home.
- Please remember that while class is in session, you should not peek in through the windows – this distracts the dancers.
- Please be respectful in the lobby and waiting areas, using “inside voices” and going outside for phone or other personal conversations. This includes properly supervising siblings and making sure they are safe and under control in all areas.
- You are responsible for reading all notices, emails, and communication sent out from the studio. Please check your child's bag for notices that may have been sent home by the teacher or office.
- Please review our studio policies with your children to help them understand why it is important for everyone to follow the studio rules.
- You and your family are expected to always follow iDance policies and guidelines.
- Please remember that if you wish to speak to your child's teacher, contact the office to set an appointment; he/she is obligated to start the next class on time but will gladly contact you later.
- Please be sure to clean up after your family and respect studio property.
- Please pay accounts on time. This allows the faculty and staff to focus on what is important, your child's dance instruction and experience.
- Please abide by the same rules of conduct that we ask your students to follow regarding being polite and respectful. This includes using appropriate language and tone with faculty, staff, and other parents and students. Please avoid gossip that may spread misinformation and please do not compare your child to other students or discuss such comparisons with other parents.

2026-27 RELEASE OF LIABILITY & MEDIA RELEASE

In consideration of being permitted to participate in dance classes and associated programs (the "Activities"), whether engaged in any and all spaces used by iDance or elsewhere, such as my own home, I hereby release, waive, discharge Institute for Dance, Inc., also known as iDance, its affiliates, officers, agents, or employees (collectively, "Releasees") from any and all liability, claims, demands, actions, and causes of action of any kind or nature arising out of or related to any loss, damage, illness (including any COVID-19 variant), or injury, including death, that I or any of my property may sustain resulting from my participation in or in any way connected with my participation in such Activities, regardless of whether such loss is caused by the negligence of the Releasees and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, and covenant not to sue the Releasees based on the same. This includes injury or damage that may occur on the premises where I engage in the Activities before, during or after classes and events.

It is my express intent that this Release of Liability & Media Release ("Release") bind my family members, spouse, heirs, assigns, personal representatives, and anyone else entitled to act on my behalf to the extent they act on my behalf, and is deemed as a release, waiver, discharge, and covenant not to sue the Releasees.

I understand that participation in the Activities involves an inherent risk of personal injury, illness (including any COVID-19 variant), and even death, and I hereby elect to voluntarily participate in said Activities, knowing that the Activities may be hazardous to me and my property. I understand that iDance does not require me to participate in these Activities. I assume full responsibility for any risks of loss, property damage, or personal injury or illness (including any COVID-19 variant), including death, that I or my property may sustain because of being engaged in such Activities, whether caused by the negligence of the Releasees or otherwise. I hereby acknowledge that I know of no medical reason why I should not participate in these Activities.

I further covenant and agree to indemnify and hold harmless the Releasees from any loss, liability, damage, or costs, including attorneys' fees and court costs, they may incur arising out of or related to my participation in the Activities, whether caused by the negligence of the Releasees or otherwise.

I understand that iDance may wish to use photographs, videos, or images of me and/or my likeness taken during classes and events for advertising, educational, and other promotional purposes.

I hereby grant iDance and its agents' permission to use photographic portraits, pictures, digital images or videotapes of me, or in which I may be included in whole or part, or reproductions thereof in color or otherwise for any lawful purpose whatsoever, including but not limited to use on social media (Facebook, Instagram, etc.), in print (posters), and online (iDance's website), without payment or any other consideration. I hereby waive any right that I may have to inspect and/or approve the finished product or the copy that may be used in connection therewith, wherein my likeness appears, or the use to which it may be applied. On behalf of myself, my heirs, representatives, executors, and assigns, I hereby release, discharge, and agree to indemnify and hold harmless iDance and its agents and affiliates from all claims, demands, and causes of action that I have or may have by reason of this authorization, including any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said photos or videotapes, or in processing tending towards the completion of the finished product.

I will notify iDance if any changes to my situation occur that will impact the permissions I have given in this Release.

I further covenant and agree that this Release shall be construed in accordance with the laws of the Commonwealth of Virginia and that any mediation, suit, or other proceeding relating to this Release and any activities covered hereby must be filed or entered into only in the Circuit Court for the City of Williamsburg and the County of James City, Virginia, and I waive any objections to such venue. Any portion of this Release deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the Release as a whole to the full extent authorized by law. This Release is my complete understanding regarding the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, regarding such subject matter.

I have carefully read this Release of Liability & Media Release in its entirety and fully understand its contents. I understand that this is an assumption of risk and release of liability, and I sign it of my own free will. I certify that I am suffering under no conditions or previous injuries that would prevent my safe participation in these Activities or potentially lead to my injury or the injury of another participant or individual.

_____ I understand that tuition will remain the same regardless of class format (in-person or virtual) changes due to health or other emergency situations.

_____ I understand failure to pay tuition on time will result in appropriate late fees and possible removal of my student(s) from class in accordance with the iDance Policies & Guidelines.

_____ I understand that if my account becomes delinquent, my bill may be sent to a collection agency, and I will be responsible for all business and legal fees incurred.

_____ I understand that consistent delinquency will be addressed on a case-by-case basis and may result in enrollment contingent on payment by semester or annually.
